Presidents Report 2022 Judo Sask AGM

It has been an honor to be your President during the past year. The Judo Saskatchewan Board of Directors conducted five meetings and held numerous votes via e-mail, since the last AGM and I participated and chaired all Directors meetings. In addition I have participated in all finance and selection committee meetings. I have been an active member of the Finance Committee, an active adviser to the Participation & Development Committee and Chair of the High Performance Committee and the Coaching Development Committee and performed the administrative duties as required.

Judo Saskatchewan does not have a paid administrator and there is work required to be done. The majority of these administrative tasks are completed by myself. A detailed review indicated that the cost for a ½ time position would be equivalent to \$50 per member per year. It was the decision of the Board of Directors to not pursue a paid staff member and that I would continue doing the tasks as a volunteer.

Judo Saskatchewan registration numbers are down as we had 460 in 2021/2022 vs 690 in 2019/2020. Reduced registrations are down all across Canada and Judo in Canada estimates it will take four years to get up to pre 2019 numbers. In Saskatchewan we have lost a number of clubs and we have lost a number of coaches. We need to find a way to support young coaches to undertake coaching and open a club.

The Bylaws approved in November 2021 separated the governance and operations. Following this AGM the incoming Board of Directors will not have a Chair of Coaches or a Chair of Participation & Development but will have two extra Directors at Large who will be assigned responsibilities in addition the duties required of a board member.

The members at the Annual membership meeting will elect the Board of Directors to govern Judo Saskatchewan which includes developing policy. On January 29, 2022 the Board of Directors approved and published the Committee Policy.

Within 21 days of the AGM the incoming Board of Directors will appoint the following Chairpersons. Within 21 days of appointing the Chairperson the Board of Directors will appoint committee members.

- Grading Committee Chairperson
- Kata Committee Chairperson
- > Referee Committee Chair
- High Performance Committee Chair
- Participation & Development Committee Chair
- Coaching Development Committee Chair
- Sanction Committee Chair

It is the sole responsibility of the Board of Directors to appoint Chairpersons and appoint committee members. All committees will be effective January 1st following the AGM that elects the President and normally be for a two-year term, unless otherwise established by the Board.

Western Canada Summer Games: Judo was a part of these games and we have now been advised that after 44 years they have been suspended. The reason for cancelation is a lack of interest from the provinces.

From the last AGM until October 20, as President I have participated in seventy (70) Zoom meetings relating to judo and while I can appreciate the efficiency of a Zoom conference, it can never replace the positive element of human contact.

I would remind everyone that it is working together in a respectful manner that will lead us to positive progress. Please be kind, supportive and accepting towards everyone, in or out of judo. Being a volunteer can be hard and the volunteers all need our support.

Vice Presidents Report to 2022 Judo Sask AGM

Thank you all for the support in my first year as your Vice-president. It has been a roller-coaster of an experience and I'm looking forward to the second half of my first term.

Right out of the gates, being on this executive has given me a different perspective about being involved in this organization and the opportunities it provides for everyone that joins. As an athlete, I never respected the amount of energy and time that was required to give us the opportunities to challenge ourselves on the tatami and reward those who were successful in competition within these borders. As a part of my own club executive, I was more aware of the work needed to be done to keep the lights on and the doors open in a facility, but the level of coordination that it took to keep the clubs communicating and providing them with the information needed to give their individual athletes the opportunities to shine in this sport was a surprise. I have new respect for the work my father did as a past president of Judo Sask, while he also remained head coach of our local dojo. The hours of work I currently see being put in by all the other members of the current board of directors and the committees is truly inspiring.

Keeping up with the responsibilities of the Vice president position, while remaining on the mats every week, has challenged me to keep to my commitments to make this organization better. In the last year, my time has included attending all five of the mandated Judo Sask board meetings, numerous informal meetings, and group discussions. I also chair the discipline and complaints committee, the event sanctioning committee, and the nominating committee. A separate reports for the sanctioning committees is filed for this AGM.

Working within the language of the new bylaws have produced some discussions and explorations to how to proceed with different scenarios that have come up.

I was excited to participate in a University of Regina Onboarding study, where research for a Master's student focused on new board members of organizations within the province and their experiences.

The three-year plan developed by the executive prior to my election included ambitious goals of increasing our membership through a developmental committee. My part in this committee including approaching the Multicultural council of Moose Jaw and discuss opportunities for their members to try our sport. There was apprehension from their organization of the legitimacy and the intentions of instigating the conversation. Over the next year, we must include a more formal strategy and presentation when approaching groups that represent or assist newcomers. Our discussions at the Coaches' Retreat suggested we should rely heavily on word of mouth for communication of the benefits and opportunities within our group and I agree that we need to foster that strategy with promotional material and information to encourage anyone that shows interest in trying our sport.

Sask Games & Canada Games: As we build toward February and our involvement in both these important events, we have been working on making sure as many of our eligible athletes as possible get a chance to challenge for spots on the teams. Many of the registered members need opportunities to train with their teams and challenge for belt gradings prior to the games. The Provincial Games are a very volunteer-heavy event for our organization, with each Zone needing male & female coaches and a team manager. Just like any other shiai, the event needs timekeepers, officials and volunteers for set-up/tear down. The overall Games itself also needs volunteers prior to and during the week, so I must encourage everyone to take some time and look at the Sask Games Website. They have lists of volunteer positions that can be filled by our members. When you register as a volunteer, it will ask if you have preference of what sport you would like to be involved with and ask for disclosure of your knowledge of the sport. This information will help place volunteers where they can be most productive and gain benefit from the experience they have. Encourage your club members to volunteer for the Games. Parents and others associated with your club would also be assets to making the games a success.

Funding requests – As an executive, we have had many discussions on how the finances of this organization can best be put to use to help support high performance athletes, officials and coaches to attend out of province (and country) competitions, clinics and seminars. This season has already been very successful for the organization, with results and achievements that let our athletes shine and encourage younger and less-experiences athlete to challenge themselves and strive. We have a lot of the season still left to go and that success will continue.

The approval of an events calendar included asking for clubs for availability and commitments for dates to hold events such as tournaments, gradings, clinics, courses and camps. The biggest being the decision to go ahead with the Sask Open next January and then subsequently adding the Western Canada Open Kata Championships. The event is in Regina, but it takes support from membership across the province to make this work. I got to see the success of the inaugural Manitoba Open, and we have the experience, volunteer base, with access to facilities and equipment to make our event the showcase it has been for generations.

In closing, I thank you all for the trust and support in my first year of my first term in this position. I'm still learning and working to balance my time on the mats with the duties that come with this role. I look forward to seeing you all on and off the mats in the second half.

Independent Auditors' Report

To the Board of Directors of Saskatchewan Kodokan Black Belt Association Inc.

Opinion

We have audited the financial statements of Saskatchewan Kodokan Black Belt Association Inc., which comprise the statement of financial position as at August 31, 2022, and the statement of operations, statement of changes in net assets and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

Notes to the Financial Statements

For the Year Ended August 31, 2022

1. Purpose of the Association

Saskatchewan Kodokan Black Belt Association Inc. (operating as Judo Saskatchewan) is a provincial sport governing body, dedicated to the promotion of Judo for all and the development of competitive excellence. The Association is incorporated under the Non-Profit Corporations Act, 1995 of Saskatchewan and accordingly is exempt from income taxes under Section 149 of the Income Tax Act, Canada.

2. Significant Accounting Policies

Theses financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO) applied within the framework of the accounting policies summarized below.

a. Cash and cash equivalents

Cash and cash equivalents include short-term investments and highly liquid investments in money market instruments which are carried at the lower of cost and market value with a maturity date of three months or less from the acquisition date. These are valued at cost which approximates market value.

b. Revenue recognition

The Association follows deferral method of accounting for grants, self-help revenues and membership fees. Under this method, restricted contributions and grants are deferred and recognized as revenue received when the related expenses are incurred. Program grants pertaining to prior years that remain unused may be required to be refunded to the sponsor.

Investment income is recorded on an accrual basis.

c. Capital assets

Tangible capital assets are recorded at cost. Amortization is provided on a straight-line basis at the following rates based on the useful lives of the assets:

d. Financial instruments

The Association's financial instruments consist of cash, investments, accounts receivable, accounts payable and accruals. Unless otherwise noted, it is the Board's opinion that the Association is not exposed to significant interest or credit risk arising from these financial instruments. The fair value of these financial instruments approximates the carrying value unless otherwise noted.

2. Significant Accounting Policies

e. Donated services

The operation of the Association is dependent on voluntary services. Since these services would not normally be purchased by the Association, and because of the difficulty of determining the fair market value of donated services, these donated services are not recognized in these financial statements.

Vice President Finance Report 2022 Judo Sask AGM

The 2021/2022 fiscal year closed on August 31, 2022. In 2021/2022 we received general funding from Sask Sport in the amount of \$172,000 and Membership Assistance Program (MAP) funding of \$26,500. Our overall budget was set at \$415,401

The funding allocations approved by the board are aligned with 4 main Strategic objectives to Enhance 1. Participation, 2. Excellence 3. Interaction, and 4. Capacity. These strategic objectives for Judo Saskatchewan are detailed in Judo Saskatchewan's 3 year Strategic Operational Plan. These objectives are aligned with the Sask Sports annual funding provincial guidelines.

For the 2021/2022 season the MAP funds were distributed to 7 clubs and were used to support community and club-level sport development initiatives throughout our province. For the upcoming 2022 / 2023 Saskatchewan Judo Clubs are reminded to submit their Map Grant requests annually so that Judo Saskatchewan can ensure monies are distributed.

For the current 2022/2023 season, annual funding from Sask Sport was initially set to \$172,000 and MAP funding is set at \$26,100. Sask Sport provided Judo Sask with a onetime increase of \$24,400 funding allotment revising the annual funding budget to \$196,400. The overall budget revenue and expenses budgeted for the 2022/2023 fiscal year were set at \$407,739, and \$421,719 respectively having a deficit \$13,980.

The Executive met virtually in July for our annual budget planning session. 2023 / 2024 Budget submissions were received from the Chairs included the following:

- Participation and Development
- High Performance
- Kata
- Grading
- Coach Development and NCCP
- Officials Excellence
- Officials Development

Thank you to all of the chairs in your efforts to submit balanced revenue and expense budgets. These budgets were reconciled into the respective Sask Sport Revenue and Expenditure categories and submitted into the Sask Sport annual funding application and follow-up system for the 2023 / 2024 season.

For the 2023 / 2024 budget submission, Sask Sport annual funding is set at \$176,500 and MAP funding was set at \$26,800. The total budget approved was \$411,179 and this has been submitted to Saskatchewan Sport and has been approved. Based on anticipated revenue and expenditures this is a balanced budget.

The participation and development committee hosted multiple events this season. It was a struggle, as covid-19 shortened our season, and we weren't really able to get started until the spring of 2022. Although our membership numbers, and our volunteer numbers were reduced, the events we did hold, were very successful.

Novice Camp

On April 30, 2022, we hosted a Novice camp in Moose Jaw, Sk. The event was held at the Heritage Inn. We ended up with 82 participants in total. This event was a little bit different than events of the past, as we not only held on mat judo sessions for our novice athletes, but held off mat training sessions for novice tournament officials.

The on mat sessions we conducted by our provincial high-performance coach, Michael Horley. Saturday consisted of 2technical judo sessions, and an hour session of Kodomo-no Kata, with guest coach Kim Kaip. Sunday consisted of a novice tournament, with all participants receiving medals as part of our introduction to judo mandate.

The off-mat training for novice tournament officials was comprised of training sessions devoted to 'How a Tournament Works', 'Running a scoreboard', 'How to conduct Weigh-ins', 'Time Keeping', 'Mat area Management', and 'How to build and Run Draw sheets'. The participants, (17) learned a lot in the sessions. On Sunday, those that participated in the training on Saturday were able to build and run the novice tournament. This worked great, as each participant was able to gain hands on experience, and learn many different positions needed during the running of a tournament. This will be a huge asset to Judo Saskatchewan going forward, as experienced volunteers are hard to find.

Women's Retreat

We were scheduled to host a female retreat in May of 2022. We had secured former Olympian Nancy Jewitt Filteau as our guest coach, and the event was to be held in Moose Jaw, Sk. The event was to have had an entirely female contingent of coaches and participants, staying overnight at the dojo in Moose Jaw. Unfortunately, we were unable to secure enough volunteers to safely run the camp, so it was cancelled. We will attempt to host this event again in 2023.

Summer Camp

On August 14-18, 2022, we held our annual summer camp as Rosthern Jr. College, in Rosthern, Sk. We brought in former British National Team Member, and current High- Performance coach in New South Wales, Australia, David Groom. Although the camp had lower numbers than we have traditionally had

in the past, it was a great camp. We had 26 participants for the duration of the camp, with a few athletes joining us for a day or two. The athletes had 3 training sessions per day, and along with David Groom, our HP coach Michael Horley, we had numerous coaches throughout the province join us for part or all of the camp. It was very successful, and has laid the groundwork to build off to make next year's camp bigger and better.

Novice Camp 2022/23

On October 22&23 we hosted a novice camp at the Moose Jaw Judo Club. This was not an overnight camp, but was made up of 2 judo sessions on Saturday, and a single judo session held on Sunday morning. Lunch was provided on Saturday, as was a pancake breakfast on Sunday morning. The Judo session were conducted by our provincial HP coach, Michael Horley. The participants were also taken swimming, as a part of the camp. We had 36 participants, from clubs in Moose Jaw, Swift Current, Regina, Battleford and Flin Flon. The weekend also provided an opportunity for some of our novice coaches to take an active role in helping on the mats with the students on a provincial level.

Other Activities

The Participation and Development Committee was also able to provide funding under our introduction to judo mandate, for the Regina Y ne-waza tournament. We funded pizza and drink for the competitors. We look forward to the upcoming season, where we can get back to regular competitions, and fully implement our introduction to judo initiative.

The Future

The future is bright, as we are hopefully on the back end of the Covid interference. We need to continue to work together as an organization to not only build back what has been lost, but to exceed what has been previously done. Getting back to our regular tournaments and emphasis on our grassroots athletes. We need to provide opportunities for our elite athletes, but also our recreational members. We need involvement from member clubs on what they require and their ability to support increased membership. We need to tap into non-traditional sources for members, including people that are new to Canada, and indigenous groups. We need to ensure that we can support an influx of new members at the club level, and support them with quality certified coaching. We need to create more opportunities for competitions and trainings. We need to be sure that opportunities for Kata and officiating, coaching and general volunteering are open and accessible to all. We need to have committees work together for the greater good of the organization. We need to be able to support new clubs, and assist them in getting off the ground. We need to be able to support clubs in the North by providing opportunities that remove the barriers faced by these members. We all must play a role in the growth of Judo Saskatchewan. It may mean doing thing differently than we have traditionally done in the past. Judo Saskatchewan is full of hard working, dedicated volunteers, that when working together, the sky is the limit. The Participation and Development Committee is committed to supporting the future growth, by supporting participation opportunities, and by supporting the development our members to be the best they can be.

Kata Committee Report 2022 Judo Sask AGM

The Judo Saskatchewan Kata Committee was officially created in December 2021. Following the lead of Judo Canada, Judo Saskatchewan separated kata development and grading into two independent committees. The purpose of this change is because high performance (HP) kata is different than grading & needs a different focus for training of judges & HP athletes.

The JS Kata committee mission is to develop and nurture an environment where all Judo Saskatchewan members are introduced to grassroot and high-performance kata. To do this, it was important to reach the entire JS membership with a variety of informational information & activities.

The committee made some huge strides in a very short time. We successfully lobbied to have the newest Kodokan kata, Kodomo no kata added as a medal event at the 2023 Sask Winter Games. The committee also successfully hosted for the first time in Canada, a Virtual Kata Provincial Championship, enabling kata competitors to take part at provincial event through a new format in these times of restrictions.

The JS website hosts 2 pages dedicated to kata: Kata Development & Kata Judging. We have been very active on social media and by use of email to promote & share all aspects of kata with the membership. We are currently working on a JS Kata You-Tube Channel, which we will use to introduce various content of kata!

- identify and develop highly qualified national kata judges,

- assist working and developing close relationships with provincial clubs and JS Grading Committee

As we work towards our goal to develop high performance kata in Saskatchewan, there will be a need for increased financial supports for our nationally certified judges & our JS HP kata athletes.

High Performance Committee Report 2022 Judo Sask AGM

The Committee is composed of T. V. Taylor, Michael Horley, Destiny Gibney and Chad Litzenberger. I replaced the previous Chair Blair Taylor effective April 26, 2022.

The High Performance Committee replaces the Coaches Committee under the new Governance structure. Briefly the Committee manages the allocated budget, works with the Provincial High Performance Coach to develop and follow an approved multi-year High Performance Plan; is responsible for the overall development and improvement of our high performance athletes; works with the Provincial High Performance Coach to develop and follow an annual training and competition schedule; is responsible for selecting Coaches, competitors and chaperones, for all team travel; and is responsible for selecting annual athlete awards.

While under my time the Committee has developed and submitted a budget for 2023-2024; selected athletes and Coaches to USJF — USJA Summer Nationals & US Open, two Camps in Lethbridge, a fall Camp in Vernon BC and to Manitoba Open, Quebec Open & Ontario Open Competitions. The Committee also met and selected the annual athlete awards.

The Coaching Development Committee Report 2022 Judo Sask AGM

The Committee is composed of T. V. Taylor, Michael Horley, Dale Berglund and Nancy Filteau.

The Coaching Development Committee was officially approved effective January 29, 2022 under the new Governance structure. It combines the duties previously performed by the Chair of NCCP and Coach Development, both of which did not have policy covering their responsibility.

Briefly the Committee manages the allocated budget, hosts an annual provincial coach learning opportunity for all provincial level coaches; selects active provincial level coaches to attend major tournaments and clinics; is responsible for the delivery of NCCP sanctioned judo specific courses within the province; work in collaboration with Judo Canada, other Judo Saskatchewan Committees and tournament hosts to delivery professional development workshops/clinics to assist Saskatchewan coaches in maintaining their NCCP Certification.

The Committee has developed and submitted a budget for 2023-2024; selected 1 coach to attend, Alberta Provincials, 2 coaches to attend Edmonton International and two Coaches to attend a Kodomo no kata clinic in Swift Current and hosted a Coach Retreat on October 22, 2023. The coach development portion of the budget has seen funding significantly reduced while the NCCP portion has been maintained.

NCCP: The past year has been quiet course wise. A Dojo Instructor course will be held on October 28-30 in Moose Jaw. Registration for DI courses is usually low; I am hoping for eight participants. A Dojo Assistant course will be planned for the new year.

Five coaches were evaluated between January 1 and Oct 31. DA evaluations passed were Jordan Alberton, Steve Loran, Isaac Loran, and Tallissa Edwards. DI evaluation passed was Bishop Sommerfeld.

All coaches should be doing Professional Development to maintain their certification. Judo Sask holds several events through the year that can be used to earn points. These events include kata clinics, technical clinics, referee clinics and the coaches' retreat.

Sanction Committee Report 2022 Judo Sask AGM

I must first thank Lorna Snider and Mike Soares for their work on this committee over the last year. While Mike has moved out province, Lorna has remained as a great source of experience and knowledge with vetting the content in the notices for many of provincial events. The province is opening up again, and as it does this committee has gotten busier.

The province got creative with having kata competitions virtual, which has resulted in two unique submissions to this committee. The April event was successful and the second is coming before the end of the month. It's not too late, get your video submissions in if you haven't already. Deadline is November 26.

The first notice for a shiai event of the 2022/23 season has been reviewed and will be held between the writing of this report and the AGM. We wish the Regina YMCA success in their event on November 27. Making sure the years of eligibility remain consistent throughout the events and

throughout the season is important. As a committee we have suggested that competition organizers include the eligible birth years along with each age group identified in their notice. There will be a change in the actual age of most competitors as a judo season progresses, but the age division they normally compete in should remain consistent in every notice of that season.

With some help, I have created the tournament package for the Sask Open and Western Canada Kata Championships January 20, 21 & 22. The draft notices for these events are now being reviewed by Judo Canada, and I expect they will be back in the sanctioning committee's hands and out for circulation before the AGM.

Judo Sask has two other major competitions on the schedule. Swift Current will be holding their shiai on February 4 and Moose Jaw will be hosting the Judo Saskatchewan Provincial Championships on April 15 & 16. Full notices for these events will be circulated and posted on the webpage.

There are still two other vacant dates for provincial tournaments. This committee supports continuing to look for locations and venues for these events. (Potentially December 17/18, 2022 and March 25/26, 2023) We also encourage clubs to organize smaller regional or inter-club shiai or randori sessions. The committee can assist with drafting notices or setting age/belt/rule criteria. Having a full calendar of competition events is what separates us from the other combat sports in this province.

High Performance Coach Report 2022 Judo Sask AGM

Since my last AGM report we have had our first competitive season since the Pandemic. Competitions began in November 2021. (I believe I sent last year's report in a few days prior to that event). Since then, besides a brief shut down in January due to Omicron, it has been a busy season. (List of key events below). As mentioned at the awards banquet, we have had some successes within our High-Performance Program in the 2021-2022 Season; 6 athletes qualified their place for the Elite 8/National Championships, an exclusive event for athletes ranked top 8 in the U18 and Senior divisions. We have a U18 National Champion, a Pan American-Oceania Junior Medalist, Cadet World Championship representation, as well as strong and consistent performances on the Judo Canada National Circuit.

In addition to the High-Performance aspects of my role I have been working closely with Josh Wiens Chair of Participation and Development. With Josh and the P&D committee we have created opportunities for novice athletes to get together and train at 2 Novice Camps in April and a Summer Camp

This season athletes have had opportunities to be coached by Canada's Olympic Medalists Jessica Klimkait and Catherine Beauchemin Pinard, Israel Hernandez of Cuba former Olympic Champion, New South Wales State Coach Australia (internet sensation Judo Way of Life coach) and quite recently Darcell Yandzi of France former European Champion and Internationally renowned coach.

Behind the scenes when they have not been coaching at their clubs or on the road with the Squad, Judo Sask Coaches Destiny Gibney and Chad Litzenberger have been progressing towards NCCP Certification/Competition Development Coaching. After completion of various modules, mat side assessment at competitions, submission, and approval of their portfolio by Andrzej Sadej (Judo Canada, Coaching & Education Director) Destiny and Chad are now Certified NCCP Level 3 Coaches.
