U 8 Ne-Waza – *Born in 2016 or later (white belt and up)*
U10 Ne Waza – *Born in 2014-2015 (white belt and up)*
U12 Ne Waza – *Born in 2012-2013 (white belt and up)*
U14 Ne-waza – *Born in 2010-2011 (white belt and up)*

U10 Tachi Waza – *Born in 2014-2015 (yellow belt and higher)*
U12 Tachi Waza – *Born in 2012-2013 (yellow belt and higher)*
U14 Tachi Waza – *Born in 2010-2011 (yellow belt and higher)*

Draws will be made based on entries. Age and gender divisions may be combined if unsuitable numbers of athletes are registered in a particular division. Attempts will be made to get all competitors 3-4 matches in their divisions.

- Female athletes must wear a *white short sleeved* shirt under their judogi.
- Hair must be worn up above the shoulders (male and female), hair bands may not contain any metal.
- All piercings and jewelry must be removed.
- All competitors *must* have a white judogi. Blue judogis can only be worn when the athlete is the second competitor in a match.

DRAW Format Ne-Waza.

U 8 Divisions: These will be exhibition matches to allow coaches and competitors to be on the mat at the same time to learn the ne-waza tournament system. A round robin pool system will be used where each entrant will compete against the other pool members. These matches will be **1 minute and 30 seconds in length, straight time with no scoring.** All competitors will receive a medal.

U10, U12, U14 Divisions: Draws will be made for the divisions based on the entries. A round robin pool system will be used where each entrant will compete against the other pool members. Smaller pools may do a double round robin to get competitors more matches. These matches will be **2 minutes in length straight time with no scoring.** All competitors will receive a medal

DRAW Format Tachi-waza

NO tachi waza for U8 division

U10, U12 Tachi-waza Divisions: Draws will be made for the divisions based on the entries. A round robin pool system will be used where each entrant will compete against the other pool members. Smaller pools may do a double round robin to get competitor more matches. These matches will be **2 minutes in length straight time with no scoring.** All competitors will receive a medal. **NO Kansetsu-waza (armbars) or Shime-waza (chokes), no rear grip, no tani-otoshi, no sutemi or makikomi, no kubinage, no drop techniques, no sankaku gatame.**

U14 Tachi-waza Divisions: Draws will be made for the divisions based on the entries. A round robin pool system will be used where each entrant will compete against the other pool members. Smaller pools may do a double round robin to get competitor more matches. These matches will be **3 minutes with scoring.** All competitors will receive a medal. **NO Kansetsu-waza (armbars) or Shime-waza (chokes), no sutemi or makikomi unless both competitors are green belt, no kubinage, no drop techniques, no sankaku gatame.**
