**Presidents Report  
Judo Saskatchewan AGM  
November 19, 2016**

It has been an honor to be your president during the past year. The Judo Saskatchewan Executive Committee conducted three meetings and held numerous votes via e-mail, since the last AGM and I participated and chaired all meetings. In addition I have participated in all selection committee meetings. I have been an active member of the Tournament Sanction Committee, of the Finance Committee, and the Coaches Committee. On behalf of Judo Saskatchewan I have attended all meetings with Sask Sport (not their AGM) as required by our funding partner. In the absence of an Executive Director, I complete the office duties normally associated with an Executive Director.

**Judo Sask Administration:** Judo Saskatchewan continues to be on very sound financial footing and to have all the required policies in place. Our membership again had an increase to 867 members. We have 79 Yudansha which includes 8 Godan (7 with the departure on Mr. O'Sullivan) and we have one candidate for Rokudan which will be a first for Judo Saskatchewan. We do need to expand the number of both female and aboriginal members, officials, volunteers and in positions of decision making. We have both a Strategic Plan and a High Performance Plan that we need to follow.

**Judo Saskatchewan By-Laws:** On April 2, 2016 The Executive of Judo Saskatchewan approved the following policies as mandated by Sask Sport. The following policies are on the Judo Sask website at <http://www.judosask.ca/bylaws.html> and will not be included in our By-laws. There is no requirement to have policies in the by-laws and each time an amendment is required it can occur without amending the By-laws.

- Judo Saskatchewan Alternate Dispute Resolution Policy
- Judo Saskatchewan Appeal Policy
- Judo Saskatchewan Code of Conduct
- Judo Saskatchewan Conflict of Interest Policy
- Judo Saskatchewan Discipline Complaints Policy

The AGM will be asked to approve amendments to the by-laws to make this happen.

**Coach Development:** We held a Coaches Retreat in Saskatoon on October 14, 15 & 16, 2016, where we had 46 coaches register and 42 coaches attend. Just a reminder that we continue to manage a separate budget for coach development and this may be used by club coaches to develop or enhance their skills. In addition to developing individual skills, the plan hopes to have more coaches attend provincial trainings, take personal development opportunities and also have at least one club coach attend the National Championships with the team as a developmental opportunity.

**Judo Sask Calendar of Events:** The provincial championships will be held March 25, 2017 in North Battleford. We still do not have a club to host a tournament and the 2016/2017 Awards Banquet on April 29, 2017. Judo Saskatchewan will contribute \$1,500 towards the awards banquet. We will be asking clubs to host the 2017 AGM and also hold a tournament on November 18.

**Judo Canada Board of Directors:** I was fortunate to be able to attend all six major Judo Canada points tournaments as well as the Elite Nationals last year. In September I was again elected a



member of the Judo Canada Board of Directors as the Regional Director, Prairies & Northwest Territories. In addition to being a Director, I am also the Board liaison to the Referee Committee and a member of the nominating committee. The current Judo Canada dues are \$16.00 for U14 Jr Mudansha, \$26.00 for over 14 Sr Mudansha and \$36.00 for Yudansha. Starting in 2017 all fees will be \$25.00.

**Executive Committee Membership:** While I very much enjoy my involvement on the Executive it is time the organization seriously looked at succession planning. As I told the coaches at the Coaches Retreat, if I was in your fridge and you looked at my best-before-date, you would throw me out. We need people to step up and learn the day to day operation. This can be done by letting your name stand for a position, or the Executive can appoint an additional Director without portfolio until the next AGM, to allow the learning process. Please consider one of these options.

## Notes to the Financial Statements

For the Year Ended August 31, 2016

### 1. Purpose of the Association

Saskatchewan Kodokan Black Belt Association Inc. (operating as Judo Saskatchewan) is a provincial sport governing body, dedicated to the promotion of Judo for all and the development of competitive excellence. The Association is incorporated under the *Non-Profit Corporations Act, 1995* of Saskatchewan and accordingly is exempt from income taxes under Section 149 of the *Income Tax Act, Canada*.

### 2. Significant Accounting Policies

#### Basis of presentation

These financial statements have been prepared in accordance with Canadian Accounting Standards for Not-for-Profit Organizations (ASNPO) applied within the framework of the accounting policies summarized below.

#### a. Cash and cash equivalents

Cash and cash equivalents includes short-term investments and highly liquid investments in money market instruments which are carried at the lower of cost and market value with a maturity date of three months or less from the acquisition date. These are valued at cost which approximates market value.

#### b. Financial Instruments

The Association's financial instruments consist of cash, investments, accounts receivable, accounts payable and accruals. Unless otherwise noted, it is the Board's opinion that the Association is not exposed to significant interest or credit risk arising from these financial instruments. The fair value of these financial instruments approximates the carrying value unless otherwise noted.

#### c. Revenue Recognition

The Association follows deferral method of accounting for grants, self-help revenues and membership fees. Under this method, restricted contributions and grants are deferred and recognized as revenue received when the related expenses are incurred. Program grants pertaining to prior years that remain unused may be required to be refunded to the sponsor.

Investment income is recorded on an accrual basis.

#### d. Capital Assets

In order to match expenditures with grants received, capital asset purchases (net of related trades or sales) are recorded as expenditures in the year acquired.

#### e. Donated Services

The operation of the Association is dependent on voluntary services. Since these services would not normally be purchased by the Association, and because of the difficulty of determining the fair market value of donated services, these donated services are not recognized in these financial statements.

## Chair of Participation & Development Report

**Winter Camp** – We are in the planning stage for the 2016 Judo Saskatchewan Winter Camp to be held December 16, 2016 to December 18, 2016 at the High School in Watrous, Saskatchewan and is limited to the first 100 athletes in attendance. The format will be the same as last year as it worked very well. The school is confirmed and Amy Cotton, the provincial head coach, will confirm if there will be guest coaches this year. This format runs very well and we are always looking for parent volunteers for the weekend.

**Summer Camp:** We complete the summer camp for the 2016 Judo Saskatchewan Summer Camp held August 7, 2016 to August 13, 2016 in Outlook, Saskatchewan. There were just under 100 people with athletes and volunteers. The camp went very well even though the weather didn't cooperate for most of the camp. The pool was closed this year and we did rent the movie theater for the afternoon. Carnival was set up for the Tuesday and Wednesday in the week and this worked out very well given that the kids could not go to the pool this year. The kids did tons of fabulous judo during the week and the guest coaches were very helpful and motivational. An added bonus this year, everyone was able to watch the Olympics all week. There were volunteers from local parents and coaches and we could have used a couple of extra volunteers. We used the "Judo Bucks" again this year as it was very well received like last year. We handled and purchased the night time snacks again this year and dispensing them in the Chapel to the kids. We ran a talent show this year and that went over very well. We utilized our facebook page this year and they were very well received by the athletes and family members.

**Introduction to Competition:** We will continue to sponsor a newaza competition for white & yellow belts where Judo Saskatchewan purchased the medals and then provided free pizza after the completion to the U10 and U12 beginners. We plan to do the same for 2016/17 have a variety of different medal designs to keep this an interesting format. This initiative has been proven to be well received with the athletes and having the pizza party around 1230 works out well in a tournament.

**Good Will Camp:** This is a weekend camp for ages 9-13 and each club is encouraged to send two athletes male and female. This camp will be held again in 2016 and we would like to see the maximum participation of athletes and volunteer coaches.

**Camp Sponsorship:** This is a program to partially fund marginalized athletes who due to disability, social, economic factors may find the fee for camp a barrier to attending either summer and/or winter camp. There are 5x \$100 winter camp grants and 5 x \$200.00 per summer camp grants. Athletes or their club may apply.

**Judo Saskatchewan Clothing:** the new Judo Saskatchewan jackets are available for purchase through judo Sask. This item will be able for purchase by coaches, athletes, clubs and fans.

## High Performance Coach Report

Since our last meeting, the athletes and I have been busy with many events. Eighteen athletes competed in the Pacific International in Vancouver on March 4/5, 2016 and then stayed to participate in the camp. Many of the eighteen athletes competed in 2 divisions to gain experience. We came home with 17 medals. The athletes all fought well and worked hard at the camp.

At Edmonton International March 12/13 a number of athletes from across the province competed. Athletes who had attended the Pacific International Competition showed improvement. We had a strong team and all athletes fought well. It was wonderful to see young athletes come out and compete. This was a great opportunity for development and I feel in the future, we should push for all athletes to attend, especially our U14 athletes.

In April, two fifteen passenger vans travelled to Canmore for an Interprovincial Training Camp which was held April 15-17, 2016. I was unable to attend this camp but there was positive feedback that it was a great camp with high intensity and some terrific randori practice before Nationals. It would be nice to have our athletes train with out of province athletes more regularly to gain more experience.

There was a girls retreat in Lethbridge, Alberta from April 22-24, 2016. Judo Sask took 35 female athletes to train. This was a fun filled weekend for all the girls that participated. They had the opportunity to get together with other girls in the sport to train. This weekend promoted girls in sport and gave our female competitors the opportunity to just be girls. I think all girls who participated really enjoyed the experience and would love the opportunity to go again.

Leading up to Nationals I put on a few Regional Camps in both the Saskatoon and Regina areas to help prepare the athletes for the competition.

This year at the 2016 National Championships thirty-four athletes competed and we finished with 13 medals (5 U16, 3 U18, 2 U21, 1 Senior, 2 Veteran). I believe the athletes went into the competition knowing that they were able to compete with and even beat their competitors. Knowing you can win a fight and having people reinforce this idea that you are capable of competing and winning at this level has a great impact on the athletes. I feel the athlete's belief in their abilities led to a strong showing at this year's National Championships.

In August we hosted the annual Judo Sask summer camp with over 70 athletes on the mats. We welcomed two highly skilled coaches - Alex Renauld- Roy from Quebec and Josh Hagen from Ontario. I believe that this was a successful event and everyone benefited from it.

In October we had a coaches retreat with over 35 coaches from across the province. JP Cantin came out from the INS to instruct our coaches on and off the mats. Over all it was a great weekend. On the Sunday he ran a provincial training session with over 20 athletes in attendance.

With the above approval the **BY-LAWS OF SASKATCHEWAN KODOKAN BLACK BELT ASSOCIATION INC.** dated December November 21, 2015, need to be amended.
