**Presidents Report  
Judo Saskatchewan AGM  
November 17, 2018**

The Authority for Judo Saskatchewan as a nonprofit organization comes from the Non Profit Corporations Act 1995, which governs all nonprofit organizations in Saskatchewan. Among many things, the Act provides the authority and responsibility, on establishing and amending by-laws. It also provides the authority and responsibilities of the Directors. Judo Saskatchewan must file a list of Directors and Officers with the Corporations Branch within 15 days of any change being made and must file the Audited Financial Statements with the Corporations Branch prior to December 31 each year.

The Directors of Judo Saskatchewan are commonly referred to as the Executive and the Executive has the authority and responsibility to manage the Organization and must submit annual reports to the membership for approval. What follows in this and subsequent reports is the annual report to the members.

It has been an honor to be your President during the past year. The Judo Saskatchewan Executive Committee conducted four meetings and held numerous votes via e-mail, since the last AGM and I participated and chaired all Executive meetings. In addition I have participated in all finance and selection committee meetings. I have been an active member of the Tournament Sanction Committee, of the Finance Committee, the Participation & Development Committee and the Coaches Committee.

**Judo Saskatchewan Administration:** Judo Saskatchewan continues to be on very sound financial footing. This has allowed Judo Sask to apply a 2018/2019 budget increase (over and above annual increases) of 14% to Officials, and 10.29% to Excellence with 5.8% to coach development and 4.4% to athlete development. We have sound policies, and all members need to continually refer to these as the world environment changes rapidly. In the absence of an Executive Director, I complete the office duties normally associated with an Executive Director, which on occasion causes concern when I may need to remind Chairpersons that procedures must be followed or that the funds belong to Judo Saskatchewan and not to the committee.

**High Performance Coach:** Our previous High Performance Coach Amy Cotton, has decided to pursue other opportunities and we initiated a hiring process where we advertised provincially, nationally and internationally. Early in the process we applied through the Saskatchewan Immigrant Nominee Program, for authority to be able to bring in a foreign worker should the top applicant come from outside Canada. We were successful in receiving approval although it was a lengthy approval process. At the time of this writing we have completed the hiring process and selected a successful applicant, Michael Horley from Great Britain. We have made a job offer, he has accepted and he is currently proceeding to get a visa to come to Saskatchewan. The offer included our wish that he be located in or near the Regina area.

In 2013 we developed a High Performance Plan that allowed us to continue to receive a High Performance Coaching Grant (\$46,400 this year). The current plan expires in 2018 and needs to be redone/updated. It is my opinion it will impact our grants should we not complete this so it is a money issue that we need to be aware of. Judo Saskatchewan needs to ensure we are running a High Performance program for which we receive the grant. The incoming Chair of Coaches will need to ensure there is an active High Performance Plan developed. This plan will require approval from both Judo Saskatchewan and Sask Sport. When we bring in a new High

Performance Coach, we need to direct them and support them to put in place a program that supports our belief as listed in the High Performance Plan.

Judo Saskatchewan believes that High Performance Sport consists of *activities, programs and practices focused on participating/competing in sport events where **improvement** and **winning** and **excellence** is the goal (vs. participation or competing purely for fun, fitness, health, social)*

**Annual Funding Assessment:** On 27 February 2017, we received the results of our Annual Funding Assessment and as reported in my last report to the AGM one of four areas we needed to improve was the number of officials. Our current referee program has done an excellent job of raising the number and profile of our Nationally ranked referees. We are however in dire need of increasing the number of Provincially ranked referees. The incoming or returning Chair of Officials will need to ensure there are active plans to increase the number of Provincially ranked referees in the Province as stated in our Strategic Plan and to ensure we are able to meet our funding obligations and run our provincial tournaments. It will be the responsibility of the incoming Executive to ensure there is coordination between committees to ensure this happens.

**Executive Committee Membership:** The responsibilities include "...They are responsible for the administration of the financial affairs of Judo Saskatchewan and the coordination of the operation of the committees. The Executive shall act on behalf of the society for routine administrative purposes, and when expediency precludes a general meeting...". The following positions on the Executive Committee are open for election:

- **President** – must be a black belt
- **Treasurer**
- **Chair of Coaches**– must be a black belt
- **Chair of Participation & Development**
- **Athletes Representative** – elected at Team Training December 2, 2018

**Committees:** The following Chairpersons are open for election.

- **Chair of Coaches** – part of the Executive
- **Chair of Participation & Development** – part of the Executive
- **Chair of Grading**
- **Chair of Officials**
- **Chair of NCCP**

Each incoming Committee chairperson may choose to select a committee to help carry out their activities. All Chairperson are required to submit a list of their committee to the Executive Committee for review. As part of the Executive's mandate to manage the organization and coordinate the operations of the committees, they will review all committees for gender balance and regional inclusion to insure a strong and balanced organization.

**Judo Canada Board of Directors:** In June 2018 I was elected to another 2 year term on the Judo Canada Board of Directors as Director and I continue to be an active member.

## Notes to the Financial Statements

For the Year Ended August 31, 2018

### 1. Purpose of the Association

Saskatchewan Kodokan Black Belt Association Inc. (operating as Judo Saskatchewan) is a provincial sport governing body, dedicated to the promotion of Judo for all and the development of competitive excellence. The Association is incorporated under the Non-Profit Corporations Act, 1995 of Saskatchewan and accordingly is exempt from income taxes under Section 149 of the Income Tax Act, Canada.

### 2. Significant Accounting Policies

These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO) applied within the framework of the accounting policies summarized below.

#### a. Cash and cash equivalents

Cash and cash equivalents include short-term investments and highly liquid investments in money market instruments which are carried at the lower of cost and market value with a maturity date of three months or less from the acquisition date. These are valued at cost which approximates market value.

#### b. Revenue recognition

The Association follows deferral method of accounting for grants, self-help revenues and membership fees. Under this method, restricted contributions and grants are deferred and recognized as revenue received when the related expenses are incurred. Program grants pertaining to prior years that remain unused may be required to be refunded to the sponsor.

Investment income is recorded on an accrual basis.

#### c. Capital assets

In November 2017, a board motion was passed to record the purchase of a new trailer at cost and amortize using the straight-line method at:

#### d. Financial instruments

The Association's financial instruments consist of cash, investments, accounts receivable, accounts payable and accruals. Unless otherwise noted, it is the Board's opinion that the Association is not exposed to significant interest or credit risk arising from these financial instruments. The fair value of these financial instruments approximates the carrying value unless otherwise noted.

#### e. Donated services

The operation of the Association is dependent on voluntary services. Since these services would not normally be purchased by the Association, and because of the difficulty of determining the fair market value of donated services, these donated services are not recognized in these financial statements.

## **Chair of Finance Report**

The 2017/2018 financial year has been a year of leaning for me as the Chair of Finance. I want to thank both TV Taylor and Sandy Taylor for their guidance as I learned the many ins and outs of the finances of Judo Saskatchewan.

The books for the 2017/2018 fiscal year were closed on August 31, 2018 and forwarded to the auditor. In 2017/2018 we received general funding from Saskatchewan Sport in the amount of \$158,400 with MAP funding set at \$25,100. A total of nine clubs received MAP funding.

For the current (2018/19) season, general funding will be \$163,200 and MAP funding is set at \$26,200. Overall budget for the 2018/2019 fiscal year is set at \$387,947.

The Executive met in July for our annual budget planning session. Budgets from the Chairs were incorporated into the 2019/2020 season. Saskatchewan Sport general funding is set at \$168,100 and MAP funding will be set at \$25,700. The total budget approved is \$406,845 and this has been submitted and approved by Saskatchewan Sport.

## **Chair of Participation and Development Annual Report**

**Winter Camp** – We have booked the 2018 Judo Saskatchewan Winter Camp held December 21, 2018 to December 23, 2018 at the Community Center in Watrous, Saskatchewan and is limited to the first 100 athletes in attendance. The format will be the same as last year as it worked very well. The Community center is booked and the guest coach will be Warren Sieb, and with the anticipation the new head coach will be in attendance. We will be looking for a volunteer to run the kitchen and to help with the kids off the mats again this year as this format runs very well. Also we are always looking for parent volunteers for the weekend (4-5 for the kitchen and 1-2 for off the mats activities).

**Summer Camp:** We complete the summer camp for the 2018 Judo Saskatchewan Summer Camp held August 12, 2018 to August 18, 2018 in Rosetown, Saskatchewan. There were just under 100 people with athletes and volunteers. The school is amazing and location definitely meets our needs. The community had a pool for us to utilize during the week which was great and they remembered us from last year. Our partnership with this school is very positive and I continue to be impressed with the school and the staff.

Carnival was set up for the Tuesday afternoon, Wednesday and Thursday morning in the week and this worked out very well given that the kids could not go to the pool this year. The kids did tons for fabulous judo during the week and the guest coaches were very helpful and motivational.

The theatre in the basement was excellent for the talent show and movie night for the group one. The talent show continues to be a hit with the kids and we continue to get full participation with the kids.

We did have enough volunteers this year but as always the more the merrier especially for the kitchen at camp (8-10 volunteers for the kitchen – 2 volunteers for activities). Every year we will continue to request more people for the Kitchen. The food was AMAZING as per usual when TV is the Chef! All the volunteers were much appreciated and from the feedback everyone enjoyed themselves during the camp.

The “Judo Bucks” again this year were very well received by the kids with friendly competition and team work.

**Good Will Camp:** This is a weekend camp for ages 9-13 and each club is encouraged to send two athletes male and female. This camp will be held in again in 2018 and we would like to see the maximum participation of athletes and volunteer coaches.

**Camp Sponsorship:** This is a program to partially fund marginalized athletes who due to disability, social, economic factors may find the fee for camp a barrier to attending either summer and/or winter camp. There are 5x \$100 winter camp grants and 5 x \$200.00 per summer camp grants. Athletes or their club may apply.

**Judo Saskatchewan Clothing:** The Judo Saskatchewan jackets are available for purchase through Judo Sask head coach.

**Judo Saskatchewan Open – Regina, SK October 19 – 21, 2018:** The participation of volunteers was very low including the setup of mats, 50/50s and working the tables score keeping. We have purchased volunteer t-shirts for all volunteers so they can be easily identified at events. I will on continuing to seek out more volunteers for events such as the Sask Open, winter camp and summer camp. The feedback for the tournament being held in Oct opposed to Jan has been very positive and everyone I talked to prefers Oct for many reasons from weather to exams for the kids to the overall schedule of major tournaments.

## Chair of Officials Report

The Referee Committee has made great strides this season at both ends of the spectrum. Our high level referees are being noticed and selected by Judo Canada to attend National & International events. We are serious about training and growing our Saskatchewan referees for major events and support the tournaments where referees are absolutely needed, and this is being recognized by Judo Canada.

We had a record number of new (novice) referee's over the season, but there is a gap between the novice level and the National level. However, this is not a new realization. Looking at previous "Chair of Official Reports", there is a pattern of a lack of and sustainability of referee's. We have come a long way in helping develop national referees, which was a funding issue. Our focus now is to solve the decade old issue of finding new referees to take the lead of the future.

There seems to be several factors affecting the ability to recruit and keep our referee's numbers sustained (constant rule changes, technology, poor treatment of officials). One of the main issues over the past few years has been a volunteer problem, lack of commitment, motivation and even willingness to give back to the sport of Judo. This change needs to start at the club level to teach judoka there is more to the sport than just training on the mats and coaching. It's evident at every event hosted in the province. Our clubs need to do a better job of making "Jita-Kyoei" a priority within their judoka. "If everyone acts with the spirit of mutual cooperation, each person's work benefits not only himself, but also others, and attaining this together will bring mutual happiness. Activities should not be engaged in simply for self-interest." If we only focus on one dimension of the judoka, we will never succeed.

I would like to make a motion that we implement a referee requirement of Provincial C, as part of our requirements for Shodan grading. It's easy to shout out the calls from the bleachers, to which many of our athletes and coaches are guilty. The Referee Committee would love for these "bleacher referees" to put on a suit and show their understanding the rules. Not only will this benefit the tournament with increased number of officials, but in will make a better, well-rounded judoka.

This past season 2017/2018, we had 29 active referees. The breakdown of club participation is very unbalanced. Currently, 23 of the 29 active referees are from the Regina/Moose Jaw area. The Referee

Committee would like to recommend that if a club is sending athletes to compete in provincial sanctioned events, they should supply at minimum one official.

Funding for Judo Sask referees has come a long ways over the past decade. This year, Judo Sask provided an additional \$2000 for international travel. Much needed and we are very appreciative. I have expressed concerns to the JS executive that the current operating budget of \$13,500 is not sufficient to continue developing our national/international referees, and support the development of our new developmental programs. The Referee Committee is requesting additional funds be added to operating budget for travel to the Canadian Circuit events (Eastern Championships, Sask Open, Quebec Open, Ontario Open, Elite Nationals, Edmonton Int, Pacific Int, Open Nationals and Canada Cup). As our Strategic Plan states, Judo Sask will send referees to all out of province tournaments where we send competitors. Last season we had athletes at all but one event on the Canadian Circuit.

Judo Sask Strategic Plan has many recommendations for enhanced participation of referees. For us to encourage judoka to referee, we must make it an enjoyable experience. We are requesting the tournament organizers ensure the referee meeting is included in the tournament technical package and supply the referee sign-up at the registration table on event day. We also request referees be introduced at the official bow in.

Judo Sask sanctioned tournaments, have made improvements. One area that needs attention is : 1. JS will ensure a proper meeting and lunch room at all provincial competitions. In some cases, the tournament organizers did not supply sufficient food to sustain volunteers until the end of the tournament. On more than one occasion, the meeting & lunch room was a “dirty” equipment storage closet. This space is not conducive for a meeting, and is clearly unacceptable for serving & eating food. The Strategic Plan also indicates that: 2. JS will have zero tolerance for public criticism of officials at our provincial tournaments. This seems to be getting worse, not better.

We feel our new referees are important and we must make it a positive experience if we want them to continue to pursue this area. The committee will be submitting a new plan for referee development which will clarify the pathways and incentives available for all referees.
